In consideration of the acceptance of this registration form for the event listed, the participant(s) name on the form freely agrees to makes the following contractual representations and agreements:

IT IS THE INTENTION OF THIS INSTRUMENT TO EXEMPT AND RELEASE THE ROCKLIN AREA CHAMBER OF COMMERCE AND THE CITY OF ROCKLIN FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH ALLEGED OR CAUSED BY NEGLIGENCE.

The participant named further agrees to defend, indemnify and hold harmless the Rocklin Area Chamber of Commerce and City of Rocklin, their officers, directors, employees and volunteers, from any claims, demands, damages, costs, expenses or liabilities arising out of his/her participation and/or the participation of his/her officers, employees or volunteers in said activities.
