Thank you for your interest in being a Chili Cook at 2011 Hot Chili & Cool Cars!

The Chili cook-off is the biggest draw of the event and lots of fun! In order to ensure that all chili cooks are in compliance with the Placer County Health Department regulations for food vendors, please read the following rules carefully.

Call the Chamber office at 916-624-2548 if you have any questions.

Requirements

1. All chili cooks are required to attend a Placer County Health Department meeting prior to the event. Failure to do so may result in the forfeiture of your booth. Dates and times are attached to this sheet.
2. Chili booths are 10' x 10' and electricity is NOT available. A 3-sided canopy tent is REQUIRED. You must provide your own cooking stove (preferably propane), all cooking utensils, serving table and all ingredients for your chili.
3. **All ingredients must be cooked on site due to health considerations.**
4. Chili cooking only – no sales will be allowed from the booth.
5. Chili kits (spoons, bowls and napkins) will be provided by the Rocklin Area Chamber of Commerce.
6. Chili cooks must make at least 10 Gallons of Chili, although making more is recommended, as chili runs out every year.
7. Approximately 10 days before the event, you will receive a confirmation letter with a map, directions to your check-in location and your check in time.
8. **COOKING MAY NOT BE STARTED UNTIL YOUR BOOTH HAS BEEN CHECKED FOR HEALTH DEPARTMENT COMPLIANCE AND COMPLIANCE HAS BEEN MET.**

Judging

1. Chili must be ready for judging by 11:00am. Chili Kits will go on sale to the general public after judging has been completed.
2. Each chili booth will be assigned a booth number for the "People's Choice" voting which will be visible to the general public. A different secret number will be assigned to the judging samples for the judges voting.
3. The decision of the judges will be final.

I have read this page carefully and agree that I and my representatives will fully comply with all of the above requirements. I understand that any violation of these requirements on the day of the event will result in forfeiture of my booth without a refund.

Participant's Waiver, Release, Assumption of Risk and Indemnity Agreement for "Hot Chili and Cool Cars" on September 17, 2011.

In consideration of the acceptance of this registration form for the event listed, the participant(s) name on the form freely agrees to makes the following contractual representations and agreements:

1. The participant named has read the official rules and eligibility standards and understands the nature and content of the activities involved, and any potential dangers incidental to engaging in the activities.
 2. The participant named hereby voluntarily releases, discharges, waives and relinquishes any and all actions or causes of action for personal injury (including death) or property damage occurring to himself/herself arising as a result of participating in the said program or any incidental activities.

The participant named agrees that under no circumstances will he/she or his/her heirs, executors, administrators, and assigns prosecute or present for, or on behalf of, any of their officers, employees or volunteers for any of said or similar causes of action, including those which arise by the negligence of the Chamber or City, or of any said persons, whether passive or active. IT IS THE INTENTION OF THIS INSTRUMENT TO EXEMPT AND RELEASE THE ROCKLIN AREA CHAMBER OF COMMERCE AND THE CITY OF ROCKLIN FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH ALLEGED OR CAUSED BY NEGLIGENCE.
 4. The participant named further agrees to defend, indemnify and hold harmless the Rocklin Area Chamber of Commerce and City of Rocklin, their officers, directors, employees and volunteers, from any claims, demands, damages, costs, expenses or liabilities arising out of his/her participation and/or the participation of his/her officers, employees or volunteers in said activities.
 5. The participant named acknowledges that he/she has been fully and completely advised of the potential dangers incidental or engaging in the activities, and fully and voluntarily assumes the risks of engaging in the program and activities.
 6. The participant named has read this form carefully and is fully aware of the legal consequences of signing it. The Rocklin Area Chamber of Commerce and the City of Rocklin do not have or provide medical or accident insurance for persons involved in programs sponsored by the Chamber or the City.
